Given that our request from the PCC to the Diocese for :

- An earlier interview date, and
- That the Rectory not be let for a further six months appear to have either been ignored or actions taken to commit to these matters without local involvement before we discussed them last week, I would like to ask that the following items be placed on the Agenda for the APCM (and if agreed at the APCM then on the agenda for the subsequent PCC meeting/Section 11 meeting).

Given the serious difficulties in making appointments to the two Benefices in the north of the Christchurch Deanery (Ringwood and St Leonards, having no applications over three rounds of advertisement; Avon Valley Churches having two candidates refuse the post), the Pastoral Committee of the Southern Archdeaconry (or other appropriate body) and the Deanery Pastoral Committee is requested to consult fully with representatives of the three relevant parishes about the structures for ministry within the area with a view to overcoming these difficulties and providing long-term sustainable ministry to these communities which total some 30,000 people.

- Such consultation of course is subject to the Parishes of Ringwood and St Leonard wishing to be involved, but this proposal to be communicated to them as soon as possible.
- The meeting may wish to consider whether such consultation be requested immediately or deferred until the outcome of the current advertisement and interview process for the Avon Valley Churches is known.
